

NAMF Scarborough Muslim Festival 2016 Vendor Terms and Conditions

1. After the Scarborough Muslim Festival vendor contract is accepted by NAMF, the vendor will be issued confirmation.
2. The assigned space includes:
 - An 8' display table (no table covers will be supplied)
 - Company I.D. sign
 - 2 Chairs
 - Electrical outlet will be provide upon request (extra charges will apply)
3. The Bazaar hours will be from 1:00 pm to 8:00 pm.
4. Products or services sold, displayed/demonstrated in actual, printed or audiovisual manner must meet decent standards that NAMF wishes to observe.
5. All displays must be confined to the booth and cannot obstruct the view or access of neighboring displays.
6. Audio, video and multi media equipment will be monitored by NAMF personnel to maintain and ensure that a comfortable sound level is maintained.
7. Vendors may not move from an assigned booth to another booth, assume additional booth space or move booth tables, chairs, or accessories from and between other booths.
8. Fireworks or incendiary devices, fuel tanks, heating appliances must be approved in advanced by the NAMF.
9. **No unauthorized fund-raising or solicitation is permitted in the Festival and other areas of the Hall.**
10. Vendors and their staff are expected to follow Islamic standards of behavior and ethics with dealing with customers and soliciting businesses.
11. **Indemnity Clause:**
 - Vendors and their staff indemnify and hold NAMF harmless from and against all costs, damages, judgments or legal expenses which may arise from this agreement, set-up, exhibition, participation or dismantling activities during, before and after the Scarborough Muslim Festival. Vendors also assume all risks of loss, injury, theft or damage of any kind or nature whatsoever to any exhibit or component thereof; including but not limited to goods, merchandise, cash, records or any other property. Further, vendors are expressly bound, at their expense, to repair any damage, which they cause to the fixtures or the facility through unauthorized modifications or movement of their exhibit.
 - Vendors and their staff indemnify and hold harmless and respective agents against any claim or expenses arising out of the use of the exhibition premises. The Vendors understands that NAMF does not maintain insurance covering the Vendor's property and it is the sole responsibility of the vendor to obtain such insurance.
Vendor (s) and assistant (s) each MUST register for Scarborough Muslim Festival to be allowed in the Bazaar area.
12. NAMF reserves the right to retract confirmation and contract and therefore close any exhibit and eject any vendor or vendor's staff immediately from the Bazaar who/which participate(s) in illegal or un-Islamic activities, violate(s) any of the terms or conditions of this agreement and will immediately comply with instruction given by NAMF personnel.
